Hereinafter jointly referred to as 'the *Parties*'

Whereas:

- The NSTT is organising an NSTT No-Dig Event in 2017 to promote trenchless technologies;
- The potential exhibitor intends to contribute towards the NSTT No-Dig Event 2017 as an exhibitor and/or in some other way;
- The Parties have an interest in timely promotion of the NSTT No-Dig Event 2017 for the success of the NSTT No Dig Event.



Hereby agree as follows:

- The potential exhibitor will make its logo available for publication in the period between the signature of this declaration of intent and three months prior to the event:
 - on the NSTT No-Dig Event website;
 - in digital newsletters on the NSTT No-Dig Event.
 Publication of the logo on the website and in the digital newsletters on the NSTT No-Dig Event will be discontinued three months prior to the event. Likewise, publication will be discontinued as soon as it becomes clear that the potential exhibitor will not make any contribution to the NSTT No-Dig Event.
- The publication of the logo involves costs that the potential exhibitor will pay to the NSTT. The costs amount to €350 (exclusive of VAT) and will be invoiced after the signature of this declaration of intent.
- As soon as possible, the NSTT will develop the further conditions for the participation as an exhibitor and/or other contribution to the NSTT No Dig Event 2017, in cooperation with the potential exhibitor where possible/desirable.
- The potential exhibitor will make a final decision on whether or not it will contribute towards the NSTT No Dig Event as an exhibitor and/or in some other way on the basis of the detailed conditions.
- If the potential exhibitor makes a definite decision before 1 January 2017 to contribute towards the No-Dig Event 2017 by submitting a signed exhibitor contract, the amount paid will be deducted from the stand price/sponsorship amount to be invoiced. The NSTT guarantees that the exhibitor's logo will then be included in the various printed materials and advertisements.
- If the potential exhibitor does not make a definite decision before 1 January 2017 by means of a signed exhibitor contract, the amount paid will revert to the NSTT. In that case, the NSTT cannot guarantee that the exhibitor's logo will be included in the various printed materials and advertisements.
